And then there is **Eric Jasinski**, who is featured on the front page of this morning's *New York Times*, "**At Fort Hood, Reaching Out to Soldiers at Risk**" (*NY Times photo*). Eric is also counting on Courage to Resist and our supporters to cover his legal bills and more.

Happy Holidays from Courage to Resist wants **EIGHT** separate Legal Fees for **EIGHT** separate Cases. When it comes to Resisting the Unconstitutional War in Iraq (March 17, 2003 to ???), Past, Present and Future, All Resisting Soldiers, Ones convicted in a non-jurisdictional Kangaroo Court-Martial, Ones closeted in Iraq and the Ones (into the hundreds) hiding out in Canada and elsewhere. ALL of them have a Common Class Action Defense, A VERY GOOD CONSTITUTIONAL DIMENSIONAL DEFENSE rising smack dab within the BILL OF RIGHTS of the United States Constitution! A Valid **Federal Question** that the First Branch's Court-Martial(s) may not rule on, because they have **NO Article III jurisdiction to do so!**

The Constitution, U.S. Codes and Case Law state in a nutshell that this DEFENSE is a DEFENSE within a U.S. Federal Court before an Impartial Jury as to have its chance for jurisdictional fairness!

Our Constitutional Framers knew in the future the Bill of Rights was the only chance for Truth, Justice and the American Way and that has given our Resisting Soldiers a Common Bond for coming TOGETHER and Going On The Offense.
